## **SUSPENSION AND TERMINATION**

We will determine, in our discretion, whether there has been a breach of this acceptable use policy through your use of our site. When a breach of this policy has occurred, we may take such action as we deem appropriate.

Failure to comply with this acceptable use policy constitutes a material breach of the terms of use [www.angliakarting.com/about](http://www.angliakarting.com/about) upon which you are permitted to use our site, and may result in our taking all or any of the following actions:
